All players, parents, fans and organizations are asked to remember that each field is part of a neighborhood and consideration for parking, noise and trash should be a high priority. All vehicles, including buses and out of town/visiting leagues, should note that the Brookline Police Department will issue parking tickets for any vehicle that is parked illegally. Please observe all parking regulations. Organizations risk the loss of permits at locations where the Park rules and regulations are found to be abused.

# GUIDELINES FOR CANCELLATIONS OF ACTIVITY ON TOWN ATHLETIC FIELDS

Due to inclement weather and poor field conditions, the Brookline Recreation Department and Park Department reserve the right to deny an athletic activity or event from playing on a Town field. The two main purposes of this policy are to ensure the safety of participants and to prevent Town fields from getting abused and destroyed when the sod is vulnerable. Any Town of Brookline employee, Recreation Staff, Park Staff, Brookline Police Officer or any other designated person may deny use of a field and/or require an activity to stop.

Conditions that require cancellation of an athletic activity:

- 1. Standing puddles of water on the field.
- 2. Footing is unsure and slippery.
- 3. Ground is water logged and "squishy".
- 4. Grass can be pulled out of the ground easily.
- 5. Lightning.
- 6. Severe weather storms.

When games are played on fields with poor/unsafe conditions, it often will cause irreversible damage to the field. It takes months, sometimes years, for the field to get back into quality playing condition.

Teams and/or Leagues that refuse to follow this policy will be subject to the following disciplinary action:

- 1. First Offense: Written warning to team and President/Director of the organization.
- 2. Second Offense: Suspension of the team or organization from practicing on fields for one week.
- Third Offense: Forfeiture of a team or organization's privilege to either practice or play games on Town of Brookline fields for the remainder of the season.

Weather and field condition updates are listed on the Brookline Recreation 24 - hour Information Line at 617.730.2083 or check www.brooklinerec.com, click on Facility Closings.

- 1. ALCOHOL: No alcohol is allowed on any park or playground in Brookline. It is the permit holder's responsibility that no person affiliated in any way with the permit brings any alcohol to the field.
- 2. 24-HOUR INFORMATION LINE: It is the responsibility of the permit holder to contact the 24-hour Information Line at 617.730.2083 or www.brooklinerec.com prior to the reservation time to make sure that the field/space is usable. If the field/space is declared to be unusable, then any permit for that field/space is revoked until such time that the field/space is judged to be usable.
- 3. ETIQUETTE ON THE FIELD: All participants using the field under permit are expected to act in an appropriate manner at all times. Appropriate behavior is required within the neighborhoods surrounding all fields. Most fields have nearby toilet facilities. If a field does not have nearby toilet facilities individuals must refrain from toileting in any area of any field. All individuals using Brookline fields must be respectful of the people that live in area and the neighborhood as a whole.
- 4. DAMAGE TO THE FIELDS: All permit holders are responsible to repair any superficial damage or replace any divots that occur during their use of any field.
- 5. TRASH: All permit holders are responsible to ensure that ALL trash is placed in the proper receptacles at each field location. If no receptacles are present at the field, (or receptacles are full) the permit holder is responsible to remove any trash that has accumulated during their permit time.
- 6. DOGS: All permit holders are responsible to insure that all dogs accompanying their group are leashed at all times and that the person or persons

responsible for the dog clean up after their animal. Off leash hours are suspended when a field has a permitted group using the facility/field.

- 7. PARKING: ALL vehicles connected with the permit holder's organization must be parked legally. ALL illegally parked cars will be ticketed and towed as stated on parking regulation signs. Please advise all users and spectators to seek parking on adjacent streets to the permitted field. Permitted organizations that continually ignore parking regulations shall have there permits rescinded. No vehicles are allowed to park within any field in Brookline.
- 8. BROOKLINE HIGH SCHOOL: When Brookline High School Athletics is involved in a competitive match or game with another school, please be advised that this match or game must be completed without interruption regardless of permit. Permitted users waiting for a game or match to be completed should stay completely off the field surface and away from the sidelines to ensure that their participants do no impede the game that is in progress.
- 9. Please note: Inflatable equipment (bouncy apparatus, etc) is NOT allowed.
- 10. BY SECURING THIS PERMIT EACH PERMIT HOLDER AGREES TO COMPLY WITH ALL POLICIES AND PROCEDURES PUT FORTH BY THE BROOKLINE PARK AND RECREATION COMMISSION GOVERNING BROOKLINE FIELD SPACE.

The renter shall have the right to occupy and use the Premises for said purpose only. The Renter shall park all vehicles in designated parking areas.

Renter agrees to indemnify and hold harmless, the Town, its agents, servants and employees, from all loss, cost and expense arising out of any liability, for injuries or damages to persons or property sustained or claimed to have been sustained by anyone by reason of the said purpose above. The Renter shall pay for any and all damages to the property of the Town, or loss or theft of such property, done or caused by any and all persons during the term of the rental agreement.

The person who has secured the field permit must be present during all reservation times stated in the permit.

### TRASH AND RECYCLING POLICY:

Please note that bottle and can recycling receptacles are conveniently located near the entrances/exits of the following parks: Amory, Brookline Ave., Cypress Playground, Devotion, Downes Field, Larz Anderson, Lawrence, Skyline, Waldstein and Warren Playground. Permit holders, parents and coaches are expected to supervise players/parents recycling of containers.

Please plan to take your trash with you when you leave the park.

# FIELD PERMITS RULES/REGS:

All players, parents, fans and organizations are asked to remember that each field is part of a neighborhood and consideration for parking, noise and trash should be a high priority. All vehicles, including buses and out of town/visiting leagues, should note that the Brookline Police Department will issue parking tickets for any vehicle that is parked illegally. Please observe all parking regulations. Organizations risk the loss of permits at locations where the Park rules and regulations are found to be abused.

# GUIDELINES FOR CANCELLATIONS OF ACTIVITY ON TOWN ATHLETIC FIELDS

Due to inclement weather and poor field conditions, the Brookline Recreation Department and Park Department reserve the right to deny an athletic activity or event from playing on a Town field. The two main purposes of this policy are to ensure the safety of participants and to prevent Town fields from getting abused and destroyed when the sod is vulnerable. Any Town of Brookline employee, Recreation Staff, Park Staff, Brookline Police Officer or any other designated person may deny use of a field and/or require an activity to stop.

Conditions that require cancellation of an athletic activity:

- 1. Standing puddles of water on the field.
- 2. Footing is unsure and slippery.
- 3. Ground is water logged and "squishy".
- 4. Grass can be pulled out of the ground easily.
- 5. Lightning.
- 6. Severe weather storms.

When games are played on fields with poor/unsafe conditions, it often will cause irreversible damage to the field. It takes months, sometimes years, for the field to get back into quality playing condition.

Teams and/or Leagues that refuse to follow this policy will be subject to the following disciplinary action:

- 1. First Offense: Written warning to team and President/Director of the organization.
- 2. Second Offense: Suspension of the team or organization from practicing on fields for one week.
- Third Offense: Forfeiture of a team or organization's privilege to either practice or play games on Town of Brookline fields for the remainder of the season.

Weather and field condition updates are listed on the Brookline Recreation 24 - hour Information Line at 617.730.2083 or check www.brooklinerec.com, click on Facility Closings.

- 1. ALCOHOL: No alcohol is allowed on any park or playground in Brookline. It is the permit holder's responsibility that no person affiliated in any way with the permit brings any alcohol to the field.
- 2. 24-HOUR INFORMATION LINE: It is the responsibility of the permit holder to contact the 24-hour Information Line at 617.730.2083 or www.brooklinerec.com prior to the reservation time to make sure that the field/space is usable. If the field/space is declared to be unusable, then any permit for that field/space is revoked until such time that the field/space is judged to be usable.
- 3. ETIQUETTE ON THE FIELD: All participants using the field under permit are expected to act in an appropriate manner at all times. Appropriate behavior is required within the neighborhoods surrounding all fields. Most fields have nearby toilet facilities. If a field does not have nearby toilet facilities individuals must refrain from toileting in any area of any field. All individuals using Brookline fields must be respectful of the people that live in area and the neighborhood as a whole.
- 4. DAMAGE TO THE FIELDS: All permit holders are responsible to repair any superficial damage or replace any divots that occur during their use of any field.
- 5. TRASH: All permit holders are responsible to ensure that ALL trash is placed in the proper receptacles at each field location. If no receptacles are present at the field, (or receptacles are full) the permit holder is responsible to remove any trash that has accumulated during their permit time.
- 6. DOGS: All permit holders are responsible to insure that all dogs accompanying their group are leashed at all times and that the person or persons

responsible for the dog clean up after their animal. Off leash hours are suspended when a field has a permitted group using the facility/field.

- 7. PARKING: ALL vehicles connected with the permit holder's organization must be parked legally. ALL illegally parked cars will be ticketed and towed as stated on parking regulation signs. Please advise all users and spectators to seek parking on adjacent streets to the permitted field. Permitted organizations that continually ignore parking regulations shall have there permits rescinded. No vehicles are allowed to park within any field in Brookline.
- 8. BROOKLINE HIGH SCHOOL: When Brookline High School Athletics is involved in a competitive match or game with another school, please be advised that this match or game must be completed without interruption regardless of permit. Permitted users waiting for a game or match to be completed should stay completely off the field surface and away from the sidelines to ensure that their participants do no impede the game that is in progress.
- 9. Please note: Inflatable equipment (bouncy apparatus, etc) is NOT allowed.
- 10. BY SECURING THIS PERMIT EACH PERMIT HOLDER AGREES TO COMPLY WITH ALL POLICIES AND PROCEDURES PUT FORTH BY THE BROOKLINE PARK AND RECREATION COMMISSION GOVERNING BROOKLINE FIELD SPACE.

The renter shall have the right to occupy and use the Premises for said purpose only. The Renter shall park all vehicles in designated parking areas.

Renter agrees to indemnify and hold harmless, the Town, its agents, servants and employees, from all loss, cost and expense arising out of any liability, for injuries or damages to persons or property sustained or claimed to have been sustained by anyone by reason of the said purpose above. The Renter shall pay for any and all damages to the property of the Town, or loss or theft of such property, done or caused by any and all persons during the term of the rental agreement.

The person who has secured the field permit must be present during all reservation times stated in the permit.

### TRASH AND RECYCLING POLICY:

Please note that bottle and can recycling receptacles are conveniently located near the entrances/exits of the following parks: Amory, Brookline Ave., Cypress Playground, Devotion, Downes Field, Larz Anderson, Lawrence, Skyline, Waldstein and Warren Playground. Permit holders, parents and coaches are expected to supervise players/parents recycling of containers.

Please plan to take your trash with you when you leave the park.

# REFUND POLICY

Cancellations/Refunds: The Town of Brookline Park and Recreation Commission does not give credit for fields that a group does not use after receiving a permit. If the Parks and Open Space Division closes a field to all use due to weather or other causes, then a refund may be requested by contacting the Recreation Department. No rescheduling, changing of the date, time or location will be honored otherwise.

# FIELD PERMITS RULES/REGS:

All players, parents, fans and organizations are asked to remember that each field is part of a neighborhood and consideration for parking, noise and trash should be a high priority. All vehicles, including buses and out of town/visiting leagues, should note that the Brookline Police Department will issue parking tickets for any vehicle that is parked illegally. Please observe all parking regulations. Organizations risk the loss of permits at locations where the Park rules and regulations are found to be abused.

# GUIDELINES FOR CANCELLATIONS OF ACTIVITY ON TOWN ATHLETIC FIELDS

Due to inclement weather and poor field conditions, the Brookline Recreation Department and Park Department reserve the right to deny an athletic activity or event from playing on a Town field. The two main purposes of this policy are to ensure the safety of participants and to prevent Town fields from getting abused and destroyed when the sod is vulnerable. Any Town of Brookline employee, Recreation Staff, Park Staff, Brookline Police Officer or any other designated person may deny use of a field and/or require an activity to stop.

Conditions that require cancellation of an athletic activity:

- 1. Standing puddles of water on the field.
- 2. Footing is unsure and slippery.
- 3. Ground is water logged and "squishy".
- 4. Grass can be pulled out of the ground easily.
- 5. Lightning.
- 6. Severe weather storms.

When games are played on fields with poor/unsafe conditions, it often will cause irreversible damage to the field. It takes months, sometimes years, for the field to get back into quality playing condition.

Teams and/or Leagues that refuse to follow this policy will be subject to the following disciplinary action:

- 1. First Offense: Written warning to team and President/Director of the organization.
- 2. Second Offense: Suspension of the team or organization from practicing on fields for one week.
- Third Offense: Forfeiture of a team or organization's privilege to either practice or play games on Town of Brookline fields for the remainder of the season.

Weather and field condition updates are listed on the Brookline Recreation 24 - hour Information Line at 617.730.2083 or check www.brooklinerec.com, click on Facility Closings.

- 1. ALCOHOL: No alcohol is allowed on any park or playground in Brookline. It is the permit holder's responsibility that no person affiliated in any way with the permit brings any alcohol to the field.
- 2. 24-HOUR INFORMATION LINE: It is the responsibility of the permit holder to contact the 24-hour Information Line at 617.730.2083 or www.brooklinerec.com prior to the reservation time to make sure that the field/space is usable. If the field/space is declared to be unusable, then any permit for that field/space is revoked until such time that the field/space is judged to be usable.
- 3. ETIQUETTE ON THE FIELD: All participants using the field under permit are expected to act in an appropriate manner at all times. Appropriate behavior is required within the neighborhoods surrounding all fields. Most fields have nearby toilet facilities. If a field does not have nearby toilet facilities individuals must refrain from toileting in any area of any field. All individuals using Brookline fields must be respectful of the people that live in area and the neighborhood as a whole.
- 4. DAMAGE TO THE FIELDS: All permit holders are responsible to repair any superficial damage or replace any divots that occur during their use of any field.
- 5. TRASH: All permit holders are responsible to ensure that ALL trash is placed in the proper receptacles at each field location. If no receptacles are present at the field, (or receptacles are full) the permit holder is responsible to remove any trash that has accumulated during their permit time.
- 6. DOGS: All permit holders are responsible to insure that all dogs accompanying their group are leashed at all times and that the person or persons

responsible for the dog clean up after their animal. Off leash hours are suspended when a field has a permitted group using the facility/field.

- 7. PARKING: ALL vehicles connected with the permit holder's organization must be parked legally. ALL illegally parked cars will be ticketed and towed as stated on parking regulation signs. Please advise all users and spectators to seek parking on adjacent streets to the permitted field. Permitted organizations that continually ignore parking regulations shall have there permits rescinded. No vehicles are allowed to park within any field in Brookline.
- 8. BROOKLINE HIGH SCHOOL: When Brookline High School Athletics is involved in a competitive match or game with another school, please be advised that this match or game must be completed without interruption regardless of permit. Permitted users waiting for a game or match to be completed should stay completely off the field surface and away from the sidelines to ensure that their participants do no impede the game that is in progress.
- 9. Please note: Inflatable equipment (bouncy apparatus, etc) is NOT allowed.
- 10. BY SECURING THIS PERMIT EACH PERMIT HOLDER AGREES TO COMPLY WITH ALL POLICIES AND PROCEDURES PUT FORTH BY THE BROOKLINE PARK AND RECREATION COMMISSION GOVERNING BROOKLINE FIELD SPACE.

The renter shall have the right to occupy and use the Premises for said purpose only. The Renter shall park all vehicles in designated parking areas.

Renter agrees to indemnify and hold harmless, the Town, its agents, servants and employees, from all loss, cost and expense arising out of any liability, for injuries or damages to persons or property sustained or claimed to have been sustained by anyone by reason of the said purpose above. The Renter shall pay for any and all damages to the property of the Town, or loss or theft of such property, done or caused by any and all persons during the term of the rental agreement.

The person who has secured the field permit must be present during all reservation times stated in the permit.

# TRASH AND RECYCLING POLICY:

Please note that bottle and can recycling receptacles are conveniently located near the entrances/exits of the following parks: Amory, Brookline Ave., Cypress Playground, Devotion, Downes Field, Larz Anderson, Lawrence, Skyline, Waldstein and Warren Playground. Permit holders, parents and coaches are expected to supervise players/parents recycling of containers.

Please plan to take your trash with you when you leave the park.

# REFUND POLICY

Cancellations/Refunds: The Town of Brookline Park and Recreation Commission does not give credit for fields that a group does not use after receiving a permit. If the Parks and Open Space Division closes a field to all use due to weather or other causes, then a refund may be requested by contacting the Recreation Department. No rescheduling, changing of the date, time or location will be honored otherwise.
